- Charles F. Gray fonds Records of Mayor Charles Gray, including those specific to his time in office during the General Strike.
- Citizens' Committee of One Thousand Collection Pamphlets and addresses given by the Citizens' Committee of One Thousand.
- Frederick George Thompson fonds Thompson was the creator of the Loyalist Returned Soldiers Association, an anti-strike organization for veterans. Records include minutes and resolutions from LRSA meetings.

- Isaac Pitblado fonds Records from Pitblado, a member of the Citizens' Committee of One Thousand and prosecutor for the trials of strike leaders.

G. Books (Non-Fiction)

Bercuson, David, Confrontation at Winnipeg: Labour, Industrial Relations and the General Strike (1990); Bercuson explores the development of labour unions in Manitoba in the two decades preceding the strike. He also

- looks at the impacts depression and war played on the striking workers and their distrust of authority.
- Bumsted, J.M., The Winnipeg General Strike of 1919: An Illustrated History (1994); a chronological narrative of the Winnipeg General Strike featuring more than one hundred photographs and illustrations. Primary source material includes newspaper photographs, eyewitness accounts, personal memoirs, and family stories.
- Dupuis, Michael, Winnipeg General Strike: Ordinary Men and Women Under Extraordinary Circumstances (2019); Dupuis explores the background, events, and result of the Winnipeg General Strike through the use of personal artifacts from those directly involved with the conflict. This book was published to commemorate the 100th anniversary of the strike.
- Dupuis, Michael, Winnipeg's General Strike: Reports from the Front Lines (2014); Dupuis' book examines the role played by journalists during the Winnipeg General Strike via their reporting from the front lines. Both pro and anti-strike media are given exposure here, while special attention is given to a number of strike-related conspiracy theories that, according to Dupuis, were pushed by the media.
- Epp-Koop, Stefan, We're Going to Run This City: Winnipeg's Political Left after the General Strike; this book explores the political evolution of Winnipeg's Left immediately following the 1919 Strike. Emphasis is given to changes that took place during the 1920s and 30s specifically, the election of the ILP's John Queen as mayor.
- Kehler, Ken & Alvin A.J. Esau, Famous Manitoba Trials: The Winnipeg General Strike Trials: Research Sources (1990); an overview of the various trials that took place following the conclusion of the Winnipeg General Strike. Strike leaders were brought on trial by the state for various offences, including disturbing the peace, sedition, and even treason.
- Kramer, Reinhold & Tom Mitchell, When the State Trembled: How A.J. Andrews and the Citizens' Committee Broke the Winnipeg General Strike (2010); the comprehensive story of the Citizens' Committee of 1000, an organization formed by Winnipeg's business elite in order to crush the strike. According to the authors, the Committee of 1000 drew upon a wide variety of anti-labour tactics in order to present the strike as a criminal action.
- Larsen, Norm, Notable Trials from Manitoba's Legal History (2015); this book provides analysis of fifteen significant trials from the annals of Manitoba's

- legal history. The now infamous Strike trials are given special attention, and analysis is provided on the six men who were sent to prison for conspiring to overthrow the governments of Canada, Manitoba, and Winnipeg.
- Lester, David & Graphic History Collective, 1919: A Graphic History of the Winnipeg General Strike (2019); a graphic novel that revisits the 1919 Winnipeg General Strike using easy-to-read comic book panels. Special attention is given to themes of class struggle and worker solidarity.
- Lewycky, Dennis, Magnificent Fight: The 1919 Winnipeg General Strike (2019); Lewycky provides a social, political, and economic analysis of the strike, including a look at the conditions that led to its outbreak in 1919. He also discusses its after-effects, including the impact levied on workers, unions, and all three levels of government during the 1920s and 30s.
- Reilly, Nolan & Sharon Reilly, 1919 The Winnipeg General Strike: A Driving and Walking Tour (2019), written by two local historians, this book provides readers with a thematic guide to the events and historic locations of the General Strike across Winnipeg. Seventy-five photographs and two foldout maps help readers explore the city and relive the Strike.
- The Workers' Revolt in Canada, 1917-1925 (2016), Craig Heron, ed; this book, a collaboration of nine labour historians, explores the Winnipeg General Strike through the lens of the post-war labour movement in Canada (especially its evolution in the Western Canada). The authors argue that the upsurge, although national in scope, took on different appearances depending on their region.
- Walker, Jack & Duncan A Fraser, *The Great Canadian Sedition Trials: the Courts and the Winnipeg General Strike* 1919-1920 (2004), published as a joint project by the Legal Research Institute of the University of Manitoba and the Canadian Legal History Project, this book analyzes the sedition trials that followed the conclusion of the Winnipeg General Strike.
- Winnipeg 1919: The Strikers' Own History of the General Strike (2019), Norman Penner, ed; an edited collection of materials from the strike leaders, including their personal account of the events of 1919. Long considered one of the more important primary sources related to the General Strike, this collection provides a detailed look at the worker's own experiences.

- McCracken, Melinda & Penelope Jackson, *Papergirl* (2019); a children's paperback that tells the story of a 10-year-old girl who distributes the strike bulletin at Portage and Main.
- Sweatman, Margaret, Fox: A Novel (1991); a novel which looks at the lives of various individuals directly impacted by the Winnipeg General Strike. This includes men and women from the business class and those directly involved with the strike.
- Zaidman, Harriet, City on Strike: A Novel (2019); a young adult fiction that tells the story of a 13-year old boy and his immigrant family as they are drawn into the events of the Winnipeg General Strike.
