# Appendix A: Manitoba Policy Facts and Trends

#### 2012

- 6 June: Finance Minister Stan Struthers proposed amendments that would introduce small, but significant increases in provincial revenues.
- 9 June: Winnipeggers have the lowest opinion, other than Sudbury, Ont, of their cities roads in all the major cities Canada. 53% of Winnipeggers say they are "very dissatisfied" with road conditions. This is more than double the 25% national average.
- 11 June: Midwives in Manitoba say the province is not addressing its chronic midwife shortage. A recent Winnipeg Regional Health Authority report shows that up to 75% of woman seeking midwifes are turned away. The Manitoba Association of Midwives calls on the government to address recruitment and retention of this lacking profession in the province.
- 14 June: The Manitoba Government aims to reduce class sizes for Kindergarten to Grade 3 classes. By 2017, all school divisions must cap Kindergarten to Grade 3 class sizes to 20. Though 10% of a school divisions classes can be flexible, no more than 23 students will be permitted in any classroom. There will be funding available starting 2012-13 school to hire more teachers and any projects related to the initiative.
- 22 June: In a 3-year action plan, the province announces its intention to promote "Active Transportation" in the province, which includes walking, cycling and rollerblading.

- 25 June: All three levels of government (federal, provincial and municipal) have agreed to expand and renovate the Winnipeg Convention Centre. The federal government will contribute 1/3 of the estimated over \$180 million project and both the city and province will contribute \$51 million.
- 28 June: Premier Greg Selinger thanks the Hugh McFadyen who recently stepped down as leader of the Official Opposition for all his contributions to Manitoba.
- 5 July: Family Services and Labour Minister Jennifer Howard announced new changes to Manitoba's *Retail Businesses Holiday Closing Act* meaning Manitobans' will now be able to shop Sunday mornings.
- 9 July: Manitoba is reported as the best province in Canada at stopping animal abuse according to the Animal Legal Defense Fund (ALDF). This is up from third in 2010 and from second place in 2011.
- 24 July: Attorney General Andrew Swan appointed Timothy Killeen and Cynthia Devine to the provincial court in Winnipeg.
- 30 July: Reported crime in downtown Winnipeg is increasing for the fifth month in a row, and is on the way to the highest level in three years. Of the 10 categories of crime tracked by the BIZ, from January 2012 to June 2012 there were 325 police-reported crimes, compared to 262 in the same period last year.
- 3 Aug: The province announces that the Fort White by-election will be held on September 4<sup>th</sup>. This seat has been empty since July 30 when Hugh McFadyen, the leader of the Official Opposition, stepped down.
- 10 Aug: While 25,000 Canadians report tips of suspected tax fraud to CRA's National Informant Leads Program each year, Manitoba has by far the highest rate tips. 4,202 Manitobans or 34 of every 10,000 Manitobans report a lead each year.
- 14 Aug: A study published by University of Alberta shows that blue green algae is dangerous and toxic to humans. Manitoba lakes are some of

- the most toxic in the country, with highest rates of microcystin, toxic to the human liver.
- 20 Aug: With Michael Balagus stepping down in January as the Premier's Chief of Staff, Premier Greg Selinger has chosen Liam Martin to replace him. He is the son of well-known Manitoba NDP MP Pat Martin.
- 22 Aug: The number of Canadian shoppers crossing the border rose 8.1% from July 2011 to July 2012. However, retail spending in the province is also up by 2.2% and the province has seen additions of many American stores such as Bath and Body Works, Forever 21 and IKEA.
- 25 Aug: Advanced polls open today in the Fort Whyte by-election. The five contenders for the seat are: Brian Pallister (PC), Bob Axworthy (Liberal), Brandy Schmidt (NDP), Donnie Benham (Green) and Darrell Ackman (Independent).
- 29 Aug: On September 1, Manitoba Hydro's 2.5% rate increase will take effect. The Public Utilities Board approved the increase and blame low export prices for Hydro's financial situation. The total rate increase for this year will be 4.5% when combined with the 1.9% increase approved in spring.
- 5 Sept: The 2013 rent guidelines were announced by Healthy Living, Seniors and Consumer Affairs Minister Jim Rondeau. The new guidelines have set the increase in rent to be set at 1%.
- 7 Sept: Health Minister Theresa Oswald announced that Dr. Michael Routledge, a University of Manitoba graduate was appointed Manitoba's new Chief Provincial Public Health Officer.
- 9 Sept: The Lieutenant Governor Philip Lee and Premier Greg Selinger left today to Manitoba's second largest trading partner China on a ten day trade mission. They joined Manitoba business leaders as well as premiers from eight other provinces and territories.
- 14 Sept: The Manitoba Government appoints the first Allowance Commissioner, William Neville, senior scholar in Political Studies at

the University of Manitoba, under the *Elections Finances Act*. The Allowance Commissioner is responsible for allotting public funds to registered political parties, and decides when and how, these funds will be paid.

- 14 Sept: The expected NHL lockout will not only affect fans, but also downtown businesses whose profits thrive with each Winnipeg Jet's games.
- 17 Sept: A memorandum of understanding (MOU) was signed today between Manitoba and the China's Anhui Province. The MOU is an effort to strengthen economic opportunities and trade investments with a focus on agriculture and bio-products over the next 5 years.
- 22 Sept: In January 2012, the province added a new department of justice innovation as a pilot project to speed court processing times. Manitoba's Chief Provincial Court Judge Kenneth Champagne canceled this project as no improvements were made to the system.
- 27 Sept: According to new Statistics Canada figures, Manitoba continues to see strong population growth, outpacing the national average; this is mainly due to immigration.
- 28 Sept: Finance Minister Stan Struthers released the Manitoba's public accounts for 2011-12 and states that Manitoba has seen modest improvements over last years third quarter report, including improvements on Summery Net Debt and deficit projections.
- 28 Sept: The province announced that the minimum wage will be increased by 25 cents to \$10.25 per hour, as detailed in the 2012 budget.
- 2 Oct: The Manitoba jail population has reportedly doubled over the last eight years.
- 10 Oct: Despite the birth increase over the past 10 years and a 5,791 difference in the number of birth minus the number of deaths in 2011-2012 the gain has been essentially lost due to net migration of Manitobans to other provinces which was as high as 4,675. Without

- immigration, Manitoba's population would have contracted from 2004 to 2007, due to this lose.
- 12 Oct: A new provincial a new micro loans program called Recognition Counts! was announced today Immigration and Multiculturalism Minister Christine Melnick. It is intended to help internationally educated skilled workers to get their education recognized sooner and work in Manitoba faster; it will provide them with up to \$10,000, to fund: training, qualifications exams and even career or financial counselling:
- 15 Oct: Public Accounts figures have revealed six MLA's charged more than \$100,000 to taxpayers for things such as housing and travel costs. Frank Whitehead, the MLA the Pas had the largest bill at \$130,051.48; Royce Koop however, a University of Manitoba political scientist, says traveling to remote regions is expensive, but necessary and attributes to high costs.
- 17 Oct: Winnipeg will be the first municipality to introduce the national business number for any program that is in partnership with both the provincial and federal government. This number is expected to reduce red tape and streamline the process for business in dealing with different levels of government.
- 24 Oct: Manitoba's personal tax exception is below the average in Canada as the income tax threshold before paying taxes is \$8,634 in comparison to \$15,000 in Saskatchewan and \$17,000 in Alberta across the prairies. PC leader Brian Pallister says this is hurting Manitoba's working poor.
- 25 Oct: The Human Rights Museum being built in Winnipeg was criticized when the Workers Rights Consortium (WRC) released a report claiming the factory in Honduras manufacturing T-shirt for the museum was intimidating and harassing its workers.
- 31 Oct: Manitoba Public Insurance (MPI) and the Public Utilities Board (PUB) are divided on how to fund road improvement and safety projects. The conflict is over MPI's rate stabilization reserve as the

- PUB would like to take \$20 million of the \$156 million fund to a separate road safety initiative that would reduce costly claims.
- 6 Nov: Lake St. Martin First Nation students from Kindergarten to Grade 9, who were victims of the May 2011 flood, were left without a school. This occurred when their temporary school, Deer Lodge Junior High in Winnipeg was suddenly closed. The federal government, who ceased funding to some evacuees, has been urged by the Provincial Government to come up with an agreement.
- 8 Nov: A property tax increase is expected in the City of Winnipeg this year, despite the cities projected \$7.7 million surplus in 2012.
- 15 Nov: After a report from MNP consulting firm, the Manitoba Liquor Control Commission and the Manitoba Lotteries Corporation will be merged for an estimated savings of \$3 million.
- 16 Nov: With the majority of displaced individuals from the 2011 flood home, and all the structural assessments appraised, the 2011 flood is the largest recovery since the 1950s. The floods total cost will add up to \$1 billion.
- 16 Nov: The province will reduce government-appointed agencies, boards and commissions (ABCs) by 20%. 23 or 114 ABCs will be amalgamated or dissolved.
- 16 Nov: The Manitoba Government has asked the Public Utility Board to conduct a 'Needs For and Alternative To' review of the upcoming Manitoba Hydro projects such as the Keeyask and Conawapa generating stations. The review is to provide independent assessment and compare alternatives.
- 17 Nov: The new \$13.4-billion Manitoba Hydro plan to build two new power-generating dams and the billions of planned debt to finance them is being reviewed by the Public Utilities Board (PUB). The PUB has been arguing for less expensive options such as natural gas due to lower rates for natural gas in the US.

- 19 Nov: The second session of Manitoba's 40<sup>th</sup> legislature opens with the reading of the Speech from the Throne.
- 21 Nov: With electronic health records being phased into Manitoba, the ombudsman recommended strengthening the *Personal Health and Information Act* (PHIA) to ensure persons who willfully look at personal health information without appropriate authorization to be prosecuted with up to \$50,000 fines.
- 24 Nov: The Manitoba Progressive Conservatives, which serve as the Official Opposition claim that the few ambulances available in Winnipeg risks lives of Manitoban's due to long wait times. The problem stems largely from long delays of paramedics waiting in ERs. So far, Tories say ambulances have spent 4.1 years total waiting in ERs.
- 26 Nov: The Manitoba Government has introduced legislation to improve the process for Manitoba Teachers Society (MTS) to investigate and conduct disciplinary procedures when it comes to instances of unprofessional conduct.
- 27 Nov: The Manitoba Government has proposed new changes that would allow electronic documents to be used in the courts. This is proposed in an effort to the make the courts and police services more efficient.
- 29 Nov: Funding for Handi-Transit services will be expanded to four new communities: Carman, Morden, The Pas and Lac du Bonnet. This brings the number of eligible regions with this vital service to nine.
- 29 Nov: Provincial regional offices will merge and downsize in an effort to restructure and streamline services.
- 3 Dec: The Manitoba Government announced new protections for buying a new vehicle in Manitoba. It is intended to protect against false and misleading advertising, particularly regarding price and 'sticker shock.' Advertised vehicles will be required to include all fees, taxies and levies, as well as the car's model year.

- 3 Dec: The Manitoba Government introduces an amendment what would eliminate a discriminatory exemption allowing employees with disabilities to be paid less than minimum wage; however, the current 20 permits in place will continue this practice.
- 10 Dec: A Deloitte report shows Manitoba remains the most affordable province for basic utility costs in the country. Manitobans pay an average annual cost of \$2,815 for electricity, heating and car insurance, which is \$553 less than the next lowest province.
- 13 Dec: The Manitoba Government is modernizing its property registry, which the government hopes to improve services when finding and registering legal documents when it comes to selling or buying a house or a second hand car. The government will sell the Property Registry to Teranet Manitoba, which is a private company owned by an Ontario employee retirement system, for \$75 million and the company will also pay the government royalties for license to provide property registry.
- 20 Dec: The Manitoba Government's second quarter financial report was released today. The quarter financial report projects a deficit of \$567 million, which was \$107 million greater than budgeted due to pressures from family services, public safety and forest fighting costs. Revenues are projected to increase 0.3% over last year.
- 29 Dec: A massive group of Idle No More activists shut down Portage and Main on New Years Eve. Around 3 pm, 350 people took part in a traditional round dance protest in a circle around Winnipeg's famous intersection.

#### 2013

4 Jan: In an annual CIBC World Markets ranking, Winnipeg has dropped to 4<sup>th</sup> from 12<sup>th</sup> place in metropolitan areas of economic growth and performance. The city's manufacturing and construction sector are the factors cited in this steep climb in the Canadian Metropolitan Economic Activity Index.

- 11 Jan: The Manitoba Government is building a new correctional centre in Dauphin. This new centre would be to replace the 100 year old Dauphin Correctional Centre and will have a higher rate capacity to reduce overcapacity.
- 17 Jan: According to a new BMO Economics report, Manitoba is projected to grow by 2.2% this year. This report cites strength in areas such as energy, mining, and manufacturing for the projected provincial growth. Growth in these areas exceeds the Canadian provincial average by 1.7%.
- 24 Jan: After adding a new Winnipeg gaming centre, Assembly of Manitoba Chiefs Grand Chief Derek Nepinak accused the Manitoba Government of "underhanded dealings" as the centre was added despite concerns that the local casino market was saturated. The province stressed the gaming room across from the MTS centre was not a casino.
- 28 Jan: The largest Idle No More event is scheduled to protest in front of the Manitoba legislature. As part of the National Day of Action a flash mob round dance will be part of the rally.
- 31 Jan: A faster and easier electronic process is now available online for applying to the Manitoba Provincial Nominee Program (MPNP). This online utility should simplify the application process by reducing the processing time from the 10-month paper application to 4 months online.
- 1 Feb: The Manitoba Government and Ducks Unlimited Canada announced a \$3.5-million partnership to help restore Delta Marsh, one of the world's largest marshes. This restoration will improve the natural function to filter nitrogen and phosphorus. It would be the largest project of its kind in North America.
- 6 Feb: The Manitoba Government is partnering with 21 groups to make a positive impact on the environment; this will be done through leading edge technologies for recycling and pollution reduction while gaining a competitive economic advantage. \$360,000 will go to the groups

through grants from the Waste Reduction and Pollution Prevention (WRAPP) Fund.

- 8 Feb: Premier Greg Selinger completed up a 10-day trade mission in India. Manitoba and Indian business leaders met at the Mumbai World Trade Centre.
- 13 Feb: The Manitoba Government invests \$667,000 to build and upgrade recreational facilities in northern and remote communities through the government's Community Places Program. Communities can apply for 100% of their projects cost for a maximum of \$75,000.
- 19 Feb: Premier Greg Selinger announces that bilingual licence plates will soon be available in Manitoba in recognition of Manitoba's deep French roots. The initiative, administered by MPI, will be available Feb. 25.
- 22 Feb: The Manitoba Government invites Manitobans to provide feedback on the governments fight to reduce poverty and help people overcome social inclusion strategy known as ALL Aboard.
- 28 Feb: The Manitoba Liberal Party's executive director faces eight charges under the *Elections Act*. Dennis Trochim is accused of knowingly making false statements and proving misleading and false information on a few different dates in 2011 and 2012.
- 7 Mar: Finance Minister Stan Struthers announces that the 2013 provincial budget will be presented on Tuesday, April 16 when the legislature resumes sitting.
- 11 Mar: According to a report, if Bipole III is delayed any longer, Manitoba Hydro will incur even more costs to move Bipole II. The additional line is needed to keep the power flowing south. Bipole III is needed because Bipole I and II function essentially as one, due to the proximity.
- 18 Mar: The Manitoba Government, in partnership with other provinces, has secured lower prices for 6 generic drugs. It is expected to save \$9

- million annually for Manitobans and the provincial pharmacare program.
- 1 Apr: The province's new bike helmet law will come into effect on May 1. The law applies to children ages 14-17 who will face a \$50 fine for not wearing a helmet while riding or being towed on a bike.
- 5 Apr: 126 recommendations were made to the Manitoba Government in a task force report in the 2011 flood. One of the most significant recommendations was to increase the capacity of the Assiniboine River.
- 19 Apr: The Manitoba Government is working toward a new Canadian Energy Strategy. Premier Greg Selinger says other provinces can follow Manitoba Clean Energy and grants for energy-efficient furnaces and geo-thermal installation. The policy will cover the controversial Keystone pipeline.
- 24 Apr: Mayor Sam Katz claims the provincial budget failed Winnipeggers as it offers little for city infrastructure, while artificially inflating other funding. The mayor claims that the budget takes away more than it gives.
- 26 Apr: Manitoba's Official Opposition say PST hike claimed as essential to enhance flood protection is inaccurate. It claims that only 1/5 of their revenue hike have gone into flood protection since they came into power.
- 2 May: The Manitoba Government gives the Consumer Protection Office more authority in a new proposed provincial bill to reduce unfair business practices.
- 3 May: The Manitoba Government is supporting 15 new medical residency spots and expanding doctor recruitment efforts according to the Premier in an effort to ensure all Manitobans have access to a doctor by 2015.
- 3 May: Through the Partner 4 Growth program, the Manitoba Government is funding more projects to create more jobs and rural

- opportunities for families and communities. Qualifying projects will be a cost sharing initiative through the provincial program and the applicants. Applicants can include: rural municipalities, First Nations communities, non-profit organizations, and chambers of commerce.
- 6 May: A deal between Manitoba and Facebook to house its "data farm" in Headingley is officially dead. After months of site evaluations, Facebook withdrew at the last moment due to other concerns over Manitoba privacy laws.
- 7 May: New legislation, Bill 38, will make it simpler to pay fines for some offences including certain highway, liquor and wildlife offences. It will replace and modernize Manitoba's 50 year old Summery Convictions Act allowing fines to be paid without a court appearance.
- 8 May: Manitoba's Conservative Opposition promised Wednesday to stall the 1% Provincial Sales Tax hike. The Manitoba Progressive Conservatives are attempting to delay Bill 20, legislation that would allow for the tax increase without a referendum. Tory house leader says by bringing this tax hike without a referendum, the NDP are breaking the law currently standing law.
- 8 May: According to the 2011 National Household Survey, more Aboriginal Peoples call Winnipeg or Manitoba home than any other city or province. The survey showed First Nations people making up about 3.6% of the Winnipeg population and about 6.5% of the population was Metis. Provincially Aboriginal people make up 16.7% of the population, with 10% being First Nations and 6.7% Metis.
- 8 May: New proposed changes to the *Highway Traffic Act* would bring more heavy trucks and other vehicles under the National Safety Code standards. In an effort to increase safety, the legislation would expand the current the definitions of commercial trucks or public service vehicles.
- 8 May: According to the Manitoba Government, the Winnipeg Police Service will receive provincial funding for 10 new positions and 10 new cadet positions. Six new officers will focus on street patrols and

four new criminal analysts will support the new Criminal Intelligence Unit.


- 8 May: Two First Nations communities Pinaymootang and Little Saskatchewan, hit by the 2011 Manitoba flood had until now avoided any court action. In the past two weeks, these First Nations communities showed rising frustration with the pace of negotiations for compensation and formally filed lawsuits against the province and Ottawa.
- 8 May: This year MTS will spend over \$40 million to upgrade its rural telecommunications infrastructure. MTS President said the company is devoting 40% of its network spending to maintain and expand its rural networks.
- 8 May: A comprehensive status report on Manitoba children shows Manitoba has more children under 19 per capita than the rest of Canada; most are from two-parent families. High school graduation rates are rising slowly, teen pregnancy rates are dropping and the province is home to 4 times as many Aboriginal youth as the national average. However, one in nine children use food banks and many child health issues are rising.
- 8 May: According to the ruling from Justice Robert Dewar in a government dispute with the Manitoba Jockey Club, "Governments, and ministers, cannot do anything they please." Dewar ordered the Finance Minister to release funds to Assiniboia Downs raised through a levy on wagering at the track.
- 9 May: Under the new proposed amendments to the *Highway Traffic Act*, all passengers will be required to ride in a seat and use a seatbelts in all motor vehicle. Passengers in wheelchairs will also now need to be secured with a seatbelt, according to the Infrastructure and Transportation Minister.
- 9 May: There are expected to be new opportunities for growth in Manitoba's high-tech and creative industries as the government is extending the Manitoba Interactive Digital Media Tax Credit to 2016.


Also, according to Premier Greg Selinger, there will be a number of enhancements will be made to the program.

- 9 May: Winnipeg's resale-homes market rebounded in April, with 401 more properties changing hands than did so in March, according to new Multiple Listing Service (MLS) figures. While that was nearly a 40% expansion over March's sales total of 844, it was still 7% short of the 1,346 total in April 2012.
- 10 May: The Province announced extension of temporary measures meant to protect Walleye populations in Lake Dauphin and surrounding areas. There is a limited exception for Aboriginal rights holders; however some treaty elders have urged all to refrain during this critical stage of walleye spawning.
- 10 May: The Manitoba Government hosts the Safe and Caring School Leadership Forum, which brought together students, teachers, school leaders and bullying prevention expert to share strategies for a safer school.
- 11 May: With expenditures on infrastructure in the billions, Manitoba Hydro is hoping its move north will be financially successful. The Energy Minister maintains with power slated to run out in 2022, the investment is necessary. The Public Utilities Board however, expressed worry over the companies deteriorating financial situation.
- 11 May: An Angus Reid public opinion poll finds that 72% of Manitobans oppose the PST increase from 7% to 8% announced in the 2013 budget. The poll also finds that opposition to the PST hike is strong among small-business owners (92%).
- 11 May: On June 3, Manitoba will open its new Mental Health ER which is a first of its kind in Canada. The \$12.5-million Community Mental Health Crisis Response Centre will be located at the west end of the Health Sciences Centre campus. The centre expects to see 10,000 patients a year and will cut down costs and wait times for these vulnerable patients who aren't able to be properly treated at traditional ERs.

- 13 May: Manitoba introduced new legislation protecting international students by regulating all education providers recruiting and enrolling international students. International students contributed over \$153 million to the provincial economy and supported over 1,600 jobs according to a 2010 report.
- 13 May: The federal government is considering having the private sector fund the public sector through social impact bonds. These controversial bonds pay the private sector interest based on the success of the social programs the bonds are funding. If the program fails, so does the investment.
- 28 May: Telus announced its \$17 million expansion to its 4G LTE technology in Manitoba. With this investment, the company has spent \$380 million in new technology and operations. This news comes days after mounting speculation of MTS positioning itself for sales to a larger national corporation.
- 30 May: The Manitoba Government will lower funds that are allotted to political parties by 30% through the "vote tax" for this year. This was revealed in the budget implementation act and will keep minister's salaries higher than previously legislated during deficit periods.



Figure 3: Provincial Revenues, Expenditures, and Surplus/Deficit 2004/5 - 2013/14 (Millions of Dollars)


